## Universal Employee Fund (UEF)

UEF is an internal fundraising campaign where hospital employees contribute funds to the Lexington Medical Center Foundation. These funds are available to assist fellow employees in an emergency or severe hardship as well as to provide items and services that enhance patient care. Additionally, funding is used to support Pastoral Care, the Cancer Care Fund and many other programs. *Be the Difference* in 2014 and support UEF!

### What is the Foundation?

The Lexington Medical Center Foundation is a non-profit 501(c)(3) organization that raises money internally through the UEF campaign and externally with support from community members. The Foundation uses 100 percent of contributions to advance its mission and positively affect patients, staff and community members.

### Where does the money go?

*All proceeds go back to employees, patients and community members. Contributions may be designated to one or more of the following areas:*

- **Emergency Care Fund** – Assists fellow employees in an emergency or severe hardship.
- **We Care Fund** – Helps to fund services and equipment for patients when they need it most. Employees are encouraged to submit grants with their suggestions to enhance patient care. For example last year, this fund also provided 1,454 medication vouchers to indigent patients and 94 workouts for cancer survivors.
- **Undesignated** – Supports these and many other programs:

## How may I contribute to the Foundation?

## Where is the Foundation located?

The Foundation is located across from Human Resources inside the Highway 378 entrance to the hospital.

## What are the benefits of giving?

With a minimum gift of \$50, four hours of annual leave or \$5 per pay period, donors receive a Foundation gift, a ticket to the UEF celebration lunch, recognition on the Donor Wall, and the opportunity to win annual leave and other great prizes. Continue to *Be the Difference* and help the community thrive!

## What is the Donor Wall?

The Donor Wall is a display located permanently in the North Tower Lobby that recognizes contributions to the Foundation. One of the four displays is dedicated to UEF donors.

## What is the Founder Society?

The Founder Society is a group of individuals who give \$1,000 or more annually to provide additional resources that support the Foundation's mission of assuring high value, quality health services and patient-centered care to members of the community. Their generosity enables the Foundation to achieve goals not yet reached and continue programs that have helped so many people.

- Founder Society (\$1,000) members receive two tickets to exclusive receptions and donor appreciation functions, invitations to Foundation events and photographs with guest speakers.
- Gold Founder Society (\$2,500) member benefits include two tickets to exclusive receptions and donor appreciation functions, invitations and four tickets to Foundation events, photographs with guest speakers, and preferred parking at the hospital.
- Diamond Founder Society (\$5,000) members receive four tickets to exclusive receptions and donor appreciation functions, invitations and table sponsorship for Foundation events, photographs with guest speakers, and preferred parking at the hospital.
