# Frequently Asked Questions

## What are the preferred qualifications for candidates?

Candidates must have completed or anticipate completion of a bachelor's degree in health care administration, health services management, public health, business administration, business management or other related programs. Qualified candidates will be team oriented and selfstarters who are knowledgeable of the health care industry.

The candidate will preferably have a graduate degree and 1-3 years working experience in health care, and experience in a physician practice or setting that allowed for patient and physician interaction. Working experience may be through internships, preceptorships, residencies or employment.

#### What is the goal of the Practice Administrator Fellowship Program?

Our goal is to immerse fellows in the industry standards of physician practice administration established by Lexington Medical Center and the Medical Group Management Association's Body of Knowledge. We provide the content framework and initiate health care management experience required for future board certification as a certified medical practice executive (CMPE). Although employment is not guaranteed upon program completion, the fellow will receive experiential learning, an inside view of our health organization, and potentially an employment opportunity as a physician practice administrator within the Lexington Medical Center Physician Network.

#### What will I be doing as a Fellow?

Fellows receive hands-on practical experience working within all areas of physician practices and community medical centers. In addition, they participate in a range of direct tasks and projects with the Lexington Medical Center Physician Network and community medical center leadership.

# What types of projects can I expect to complete?

Multiple projects are required as part of the core curriculum whereas others originate from executive leadership based on organizational needs. Examples of past projects include: key indicator ratios, revenue cycle analysis, physician practice workflow time study, and patient satisfaction assessments.

#### Who serves as preceptors to the fellows?

Preceptors are practice managers currently working within Lexington Medical Center, assigned to guide individuals through their learning experience during the Practice Administrator Fellowship Program. Fellows will have a close relationship with the primary preceptor throughout the program year along with secondary preceptors during project assignments and practice rotations.
